**TIE-BREAK**

In the event of any oversubscription in the number of applications made under any of the categories above, the Governing Body will offer places firstly to children aged 3 before 1<sup>st</sup> September, then children aged 3 before 1<sup>st</sup> January and children aged 3 before 1<sup>st</sup> April whose family home is nearest to the school. The measurement shall be done in a straight line using a Geographical Information System (GIS)

Applications received after the closing date will be allocated on a first-come, first-served basis only if places are still available. If the nursery is full, the child's name will be added to the waiting list which will be held in order of the criteria detailed above.

If we are unable to offer your preferred day/time, you may be contacted and offered an alternative. A response will be required within 24 hours before the alternative will be withdrawn in order that it can be offered to the next eligible applicant.
